



AUSTRALIAN SUBMARINE AGENCY INDUSTRY UPLIFT PROGRAMS

Australia's acquisition of conventionally-armed, nuclear-powered submarines is one of the most significant industrial transformations in the nation's history.

The Australian Government has established a suite of industry uplift programs to support the development of a resilient and sovereign Australian Submarine Industrial Base. These initiatives are designed to integrate Australian industry into UK and US supply chains, ultimately enabling the build and sustainment of Australia's nuclear-powered submarine capability.

These complementary programs are supported by targeted government investment, strategic trilateral partnerships, and a prioritisation framework that aligns with broader Defence strategic policy. Together, they offer a flexible suite of pathways tailored to the unique requirements of Australian businesses seeking to participate in nuclear-powered submarine opportunities.

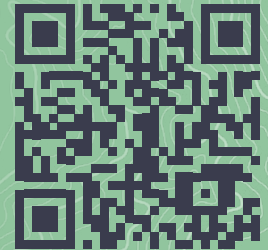


INDUSTRY CAPABILITY PROGRAMS

The industry uplift framework integrates bespoke programs with existing Commonwealth initiatives such as the Global Supply Chain Program and Defence Industry Development Grants, to provide scalable support for Australian businesses.

AUSTRALIAN INDUSTRY FRONT DOOR

To help industry navigate the right journey for their business, ASA provides a concierge service through the Industry Front Door. The ASA leads regular trade delegations to the UK and US, offering Australian businesses direct access to both US and UK Government and Industry representatives, and facilitating clarity around current and future demand signals.

DEFENCE INDUSTRY VENDOR QUALIFICATION PROGRAM

OVERVIEW

Launched by the Australian Government in 2024, the Defence Industry Vendor Qualification (DIVQ) Program is a Government initiative, delivered in partnership with industry. Initially focussed on the US, the Program streamlines the qualification of Australian businesses to provide products and services into trilateral supply chains.

APPROACH

DIVQ enables qualification activities to be undertaken in Australia by US shipbuilders in partnership with ASC. Through this process, Australian suppliers that meet the assessment and quality standards established by General Dynamics Electric Boat and Huntington Ingalls Industries Newport News Shipbuilding can qualify for inclusion in the US Supply Catalogue. Ultimately, this provides Australian businesses with access to future commercial opportunities within the US supply chain.

AUSTRALIAN SUBMARINE SUPPLIER QUALIFICATION PROGRAM

OVERVIEW

The Australian Submarine Supplier Qualification (AUSSQ) Program is a business-to-business initiative delivered by Huntington Ingalls Industries (HII) Australia in partnership with H&B Defence. Designed to qualify Australian suppliers for access to opportunities across US and UK supply chains, AUSSQ supports Australian suppliers to meet the rigorous technical, regulatory, and security standards required to participate in the nuclear-powered submarine program.

APPROACH

US Work Packages: Structured around a disciplined sequence of validation, uplift, and qualification processes, the AUSSQ Program enables Australian suppliers access to compete directly for HII Newport News Shipbuilding supply chain opportunities.

UK Sustainment Services: Supporting Australian suppliers to deliver priority sustainment services to UK submarines participating in Submarine Rotational Force – West activities, the AUSSQ Program will provide validation and qualification of Australian vendors to the Babcock UK approved supply chain.
